

\$262,369 Donated to Durham Hospital in 2019 by Foundation



Thanks to generous donors, the Durham Hospital Foundation was able to purchase several pieces of equipment for the Durham Hospital in 2019.

These included a central cardiac monitoring system, new ventilator/bi-pap machine, two new IV pumps, a hematology and a coagulation analyzer and centrifuge for the lab, six new wheelchairs and a set of physiotherapy stairs.

The new wireless cardiac system monitors up to six patients' heart rates and breathing at the same time, turning every room into a cardiac care room. This allows nursing staff to monitor all patients from a central point—the nursing station. When a patient's vital signs change outside of acceptable levels, an alarm sounds allowing staff to respond quickly.

When changes to heart rhythm and breathing are caught immediately doctors can respond with the right treatment options, enhancing the chance of a full recovery. The cardiac monitoring system is vitally important to patient care and recovery.

The bi-pap ventilator supplies pressurized air into the airway. The machine can simply help a patient breath or take over completely for a short time. It is considered to be non-invasive because the air is supplied through a mask and not a tube.


The new lab equipment is all related to bloodwork—checking white blood cell levels and establishing complete blood counts, both of which are important in cancer treatment as well as testing the blood's ability to clot.

The new wheelchairs replace missing and older chairs, they are set up to carry oxygen tanks, are easy to handle and easier to clean and sanitize.

The physio stairs are used after some health incident that required hospitalization, helping patients regain strength, balance and demonstrates the ability to successfully and safely do stairs before being released to their homes.

None of this would have been possible without the generous support of donors, sponsors, corporate and community partners and the generous gift left by Gerda Meyerink in her Will.

Cardiac Monitoring System



Every day, between twenty-five and forty people visit the Durham Hospital's Emergency Department. Many of those are ultimately admitted to the hospital. Six to ten of those people are at risk of a cardiac event.

Both of the ER's cardiac monitoring units were often in use when people came to the ER with breathing difficulty or chest pain. If more patients came in needing to be placed on a monitor, doctors had to prioritize who needed it more.

With the two monitors aging and parts becoming impossible to find, it became critical to replace the units.

\$174,000 was provided from donations to purchase a new central cardiac monitoring system. This wireless system monitors the heart rate and activity of up to six patients for an extended length of time.

Two of the units are set aside for use in the ER with the remaining four being used for inpatients. Because the system is wireless, the transponders can move with the patients, making every room into a cardiac room.

The monitor screen is larger and more vibrant than the older model and all six units can be viewed at the same time. The new technology provides many options for staff, including a function for training. This ensures that all staff involved in patient care will be skilled and able to react quickly and knowledgably.

This life-saving system monitors several vital signs, records them and can create a printed record, if needed for analysis. An alert sounds at the nursing station, allowing staff to respond instantly if any critical changes are detected.

When an alert is raised, life-saving treatment can be administered immediately.... and, when seconds count, those few seconds can make such a difference!

Story of a Legacy Gift- Gerda Meyerink

When young, Gerda lived in Holland with her husband Henk, a skilled baker. When Henk had to leave his profession for his health, the family immigrated to come to Canada where he could start his own business, a true entrepreneur.

Arriving in Drayton in 1953, they found old friends, Henk and Jean Koeslag, living near Durham and followed them to the area a year later. Henk was able to purchase a chicken farm on Hwy 6, south of Durham to start over.

Bev and Diane Neff lived nearby and became close friends, with Bev helping out the newcomers whenever he could. This friendship meant a lot to Gerda and Henk. With no siblings or children, being able to count on friends was important.

Gerda and Henk travelled though the U.S. and Canada on vacations, visiting every state and British Columbia several times. They loved their camping trips to truly 'see' the countries. They also visited Australia and New Zealand.

In 2010, Gerda fell while shopping in Owen Sound, hitting her head quite hard. She was eventually sent to London with a serious concussion, where she stayed for several weeks.

When Gerda finally came home, Henk found it difficult to properly care for her and run the farm, too. Gerda moved to Serenity Place in 2011 and Henk joined her there in 2012. After Henk passed away in 2014, Bev Neff began taking watching out for Gerda. Bev's daughter Andrea moved into the role after Bev passed away until Gerda's own passing in 2019.

Gerda and Henk both felt a deep commitment to and respect for their new community and to their local hospital. Gerda especially was most grateful for the level of care she received after her



fall and in her declining years. Gerda showed that commitment in her Will, leaving gifts to several local organizations, including a most generous gift to the Durham Hospital Foundation.

The Foundation appreciates Gerda's generous support for the Durham Hospital. Her gift showed how important it was to her to support and keep our local hospital up to date, with quality equipment and facility.





Mental Health Safe Room

The 2019 Christmas Campaign raised all the funds needed to pay for a mental health safe room at the Durham Hospital, over \$25,000!

A safe room provides a place for staff to temporarily hold and care for patients suffering from different forms of mental illness, in a safe physical environment. The safe room includes speakers and cameras so staff can monitor and communicate with the patient, a 2 way door, shatter proof glass, and in-room

washroom—features that help ensure the patient is kept comfortable, safe and secure and is treated with dignity while being cared for.

The safe room will be used when patients show signs of depression, aggression or suicidal tendencies, if they are a threat to themselves or to others within our facility.

This special room will improve staff's ability to safely treat the increasing volume of mental health patients and



allow patients to de-escalate in a safe environment with few or no stressors.
